In accordance with the By-Laws of The Transplantation Society, this letter is to notify you of the impending elections of Officers and Councilors-at-large and to seek nominations to fill the positions being vacated at the 31st International Congress of The Transplantation Society in Sydney, Australia in September 2026. The Council and its Officers are important to TTS' fulfillment of its strategy and mission. We are therefore seeking nominations of highly qualified and dedicated individuals to ensure the continued success of TTS.

All nominations must be received at the TTS International Headquarters in Montreal no later than February 18, 2026.

TTS OFFICERS AND COUNCILORS-AT-LARGE

TTS is seeking nominations for three Officer positions that will be vacated in 2026:

- Vice President
- Treasurer

Full members in good standing may nominate someone for these positions. If you wish to nominate someone, please complete the appropriate attached form. Only Councilors-at-large who are in good standing and who have served at least one full term may be nominated to an Officer position. For the Councilor-at-large position, full members in good standing may be nominated. To nominate someone, the person nominating must also be a full member in good standing.
